

Clinical Practice: Frequently Asked Question

Q: Is there a minimum amount of time a pt is to be held in Ph 1 PACU before discharging to Ph 2?

- adults
- pediatric

A: Consensus of the American Society of Anesthesiologists Task Force on Postanesthetic Care is that a mandatory minimum stay is not necessary and that the length of stay should be determined on a case-by-case basis. ASPAN does not have a specific recommendation on the patient length of stay in the PACU.

There are several factors to consider when evaluating the patient's status for discharge from any phase of care. Some of these factors identified in the ASPAN practice Recommendation Components of Assessment and Management for the Perianesthesia Patient include, but are not limited to:

- airway and respiratory/ventilation status
- cardiac and hemodynamic status
- thermoregulation
- level of consciousness
- level of pain
- level of sedation
- condition of dressing/surgical site
- patient safety needs
- intake and output
- emotional status
- child-parent/family interactions
- postanesthesia scoring scale, if used
- discharge instructions reviewed
- arrangements for transition of care
- arrangements for safe transport

Guidelines for discharge criteria should be developed for each phase of PACU care. In determining guidelines for discharge, collaboration between the anesthesia department, the medical staff, the PACU staff, and administration is essential to establish clear expectations.
