Historical Perspective

- 1971- Richard Nixon- National Cancer Act
 - Disparity in access to treatment due to economic, social and cultural factors
 - Timely access from dx to ttt
- 1990 1st- Patient Navigation program-
 - Dr. Harold Freeman- Harlem, New York City
 - Eliminate barriers: financial, communication/information, medical, emotional
- · Highlights of Patient Navigation
 - Patient- centered healthcare service delivery model
 - Core function- elimination of barriers to timely care
 - One on one relationship between the navigator and the patient
 - Services- cost effective
 - Differentiate the role from other providers in the system- ex- social worker
- 2005- Patient Navigator and Chronic dse Prevention Act (HOUR 1812) signed into law by Pres. Bush

- · Care Coordination and Registered Nurses' Essential Role
 - "coordinate with members of patients' health care teams every day in the course of delivering health care services to patients, whether in acute care, long-term care, private practice, or other settings."
 - "supports the promotion and involvement of registered nurses in the development of future care coordination models"
 - "must be defined, measured, and reported to inform and ensure appropriate financial and systemic incentives for the professional care coordination role"
- ANA
 - "Function that helps ensure that the patient's needs and preferences are met over time with respect to health services and information sharing across people, function and sites."
 - Liaison between the patient and other care givers

Nurse Navigator Role - Oncology

- · Educate patient about their disease and treatment plan
- · Assess patients for psychosocial distress
- Support the timely scheduling of appointments, diagnostic testing, and procedures
- Empower patients, families, and caregivers to assume as much responsibility for care
- · Function as a member of an interdisciplinary team
- Serve as liaison to the physician for additional questions and concerns

Nurse Navigator - Hiring

- · Providing education and support to the patient and family
- Identifying special needs of the patient and delegating to appropriate support staff
- Enhancing understanding of treatment options available
- Facilitating patient care plan recommendations by physician
- · Connecting patient and family with community resources
- Coordinating multidisciplinary care from time of diagnosis throughout treatment
- · Improving timeliness of appointments
- Serving as a resource for the community on health issues, prevention, screening, treatment, and research

PreAnesthesia Evaluation Clinic

- · Goal: to assess the risks and develop the plan for anesthesia
- Elements
 - review the patient's medical history, including anesthesia, drug, and allergy history
 - assess anesthesia risk and identifying potential anesthesia problems
 - collect additional pre-anesthesia data or information
 - discussing risks and benefits and obtaining informed consent
 - developing a plan for the patient's anesthesia care as described in ASA's Basic Standards for Pre-Anesthesia Care
- necessary to optimize underlying medical conditions, perform care coordination, and/or develop medical optimization transition or bridging orders for patient safety and optimal outcomes

PreAnesthesia Navigator Role

- · Assess patients' risk for perioperative adverse outcomes
 - Guidelines and protocols
 - Assist in scheduling patient pre-anesthesia/surgery evaluation
- · Coordinate care needed after preanesthesia visit
 - PCP, Specialty consults, testing, follow up
- · Collaborates with members of surgical and multi disciplinary teams in assisting and planning of perioperative course
 - Point of contact for surgical clinics and PreOp/PACU
- · Educate patient about perioperative processes- NPO, SSI

- · In person Evaluation and Telehealth

- Surgical clinics request for an evaluation via surgical case
- Surgical clinics request for an evaluation before scheduling surgery
- RN will screen patient based on an established guidelines · Insurance coverage is necessary
- Schedulers will schedule the Inperson or Telehealth appointment
- · Some patients are scheduled by an RN
- Patients are evaluated and recommendations made by providers
 - RN will coordinate follow up care necessary before surgery date · RN assists in procurement of records if urgent

- · Laboratory results
- Diagnostic Tests- CT, U/S, Echo
- Does the patient have a Primary Care provider?
- Does the patient see his PCP on a regular basis?
- Does the patient see a specialist or have been evaluated
 - Cardiology, Pulmonology, Endocrinology, Nephrology, etc
- · Recent ED visit or Inpatient admissions
- · Recent surgery

- · Autoimmune-

- Other
 - Allergies
 - Undiagnosed
 - Polypharmacy

Assessment- Screening- Current disease state

- · What is the reason for surgery?
- Where is the location of the diseased state?
- · Will it affect major organs?
- Will it exacerbate chronic medical conditions?
- · Is it urgent?

Emergent <24 hr	High Urgency Within 1 wk	Moderate urgency Within 4 wks	Non-urgent Within 1-6 months
Without procedure patient is at high risk of cardiovascular mortality	Without procedure patient will suffer major cardiovascular morbidity or death	Without procedure patient will have peristent symptoms with potential progression to increased risk of major morbidity or death	delaying procedure, may have
Tier 0	Tier 1	Tier 2	Tier 3

Care Coordination

- · Coordinate follow up care needed by preanesthesia
 - Assist in scheduling PCP appts manage chronic state
 - Referral to specialty clinic: cardiology, pulmonary, neurology, hepatology, hematology, etc
 - Follow up visit notes and anticipate further testing
 - o Cardiac dx, pulmonary, radiology
- · Procure medical records as needed
- · Alerting Preop dept
 - Cardiac Device, Preop Infusions, MH Alert, Fetal Monitoring, other

Patient and Staff Satisfaction- Examples

- · Patient missed her appt- referred to social worker
- · Covid testing- assist patient in registering to get a QR code
- System Outage- sent patient to bring EKG and letter to Cardiologist
- · Specialty pharmacy in Florida
- · CHF- PCP not reachable-COVID outbreak in facility- dispatch was sent
- · No openings at UCHealth- find the patient an outside Endocrinologist
- Cheyenne testing is limited and difficult to schedule- Poudre
- Schedule a young person to get ECHO in Kansas
- ECHO- abnormal- Cardiacthoracic Referral- Aortic Stenosis-Cardiac Surgery uchealth

Overcoming Challenges

- · Identified key staff in various clinics to assist in scheduling
- · Worked with practice manager for Cardiology clinic to escalate scheduling than cancelling surgery
- · Create a directory of healthcare facilities in Colorado and surrounding states for patient to get their follow up tests
- Create a systematic report to keep track on what patient needs to do for surgery preparedness
- · Cross train clinic staff (MAs) to do scheduling
- · Cross train PAT RNs to cover Case Reviewer/Navigator role
- Technology- use the "quick chat" feature within the EHR when communicating to be resolve issues and concerns

- · Support for preprocedure clinic staff
 - Schedulers, Medical Assistant, Record Retrievers, PAT RN
- Support for surgical clinics- questions
- · Assist with patients preop instructions
- · Covid Orders and instructions
- · Research and PI projects
 - Anemia management
 - Spine processes
 - Penicillin allergy testing

Barriers and Challenges

- · Lack of information on patients' health record
 - Unable to conclude status during screening
 - PAT RN call supplements the health information
- Clinic staffing problems schedulers and medical assistants, providers out
- · Patient related factors
 - Transportation
 - Financial
 - Support - Disabilities
- Lack of knowledge
- Time- surgery date too close
- PCP or Specialty Clinics not able to accommodate
- Testing not available
- Unable to reach
- Non-compliant


