As I explained in my last *Breathline* column, our organization has chosen to participate in a journey toward preserving resources and the environment.

## Paper, Plastic or Digital? Incorporating Important Rs

Early childhood education has long been associated with three basic Rs: reading, 'riting and 'rithmetic. Nursing education introduced us to essential Rs of clinical practice: the RIGHT patient, RIGHT drug, RIGHT dose, RIGHT time and RIGHT route. Nursing managers and administrators learned the Rs of retention: relationships, respect and recognition.

Nearly 30 years ago, American culture was introduced to another important series of Rs: reduce, reuse, and recycle.<sup>1</sup> Today, innovative organizations are supporting the quest for a cleaner, healthier environment by seeking ways to implement the 5 Rs: **reduce, reuse, recycle, restore and rethink.**

While waste reduction is the preferable choice, exploring ways to reuse waste products is a practical alternative. The process of recycling and/or restoring is an option for materials which were neither reduced nor reused. Rethinking is perhaps the most vital step toward the preservation of planetary well-being.

### Rethinking Actions

The "Go Green" culture is gaining momentum. What does this mean? Equally important, what does it NOT mean? ASPAN is embarking on a "Go Green" journey to join forces with many other healthcare organizations and institutions.<sup>2</sup> The primary purpose of this action is to minimize environmental impact from conducting *business as usual* by engaging in a proactive state of rethinking and strategizing operations for a strong and vital future.

The world has a finite quantity

of natural resources. Researchers and scientists have shown that some natural resources are already depleted. The global population, expanding at astonishing rates, is expected to exceed 9 billion by 2050. Per capita distribution of the earth's natural resources in 2050 will allow only 25% of the resources that individuals enjoyed in 1950.<sup>3</sup>

In spite of fewer resources, the growing population continues to place strain on the limited resources. People currently "save" for college educations, orthodontia, tummy tucks, new homes and a rainy day. One of the greatest challenges facing current generations is to "save" clean air, water, fuel sources and soil for the future. This challenge falls on each of us as stewards of health and health promotion, citizens, and individuals.

### Use Less, Not More

The phrase 'paperless' is a bit of a paradox. Current healthcare infrastructure cannot adequately support a completely paperless business model. On the other hand, modifications in work practices and output will go a long way to support the vision for a healthier, cleaner world.<sup>4</sup>

The greatest threats to future resources come from things we produce and/or throw away every day. Common batteries and electronics often contain dangerous chemicals that, if sent to a local landfill, may contribute to groundwater pollution. The use of energy efficient lighting, simple adjustments to energy settings and other electrical devices produce impressive energy savings.

**What can ASPAN do?** The National Office can consider purchasing recycled products, including paper towels, napkins, printing paper and vegetable-based inks for environmentally friendly printing. In-office recycling can be done. ASPAN publications, including conference materials and certain educational materials, can be burned onto CD-ROM or posted online, rather than using traditional printing methods.<sup>4,5,6</sup>

**What can components do?** Create a plan to cut down on unnecessary or excessive publications and/or printing. Explore ways in which technology can replace travel and meeting costs. Utilize instant messaging, video conferencing, webinars or phone conferences to disseminate education or bring board members together for meetings. Organize community outreach projects, such as bottle drives or neighborhood park and playground clean-ups. Pledge component funding support for environmental projects.<sup>4,5,6</sup>

**What can individuals do?** Simplify and eliminate the excess. Ensure work units have small recycling bins. Trade shifts to work a few longer hours but fewer days a week, instead of commuting to work more often. Buy and use only what is needed. Reuse plastic cups and paper bags. Explore ways to improve energy efficiency for heating and electrical resources within the home.<sup>1,3</sup>

### Live the 5 Rs

Join ASPAN on this critical journey. Observe important guidelines to reduce, reuse, recycle,

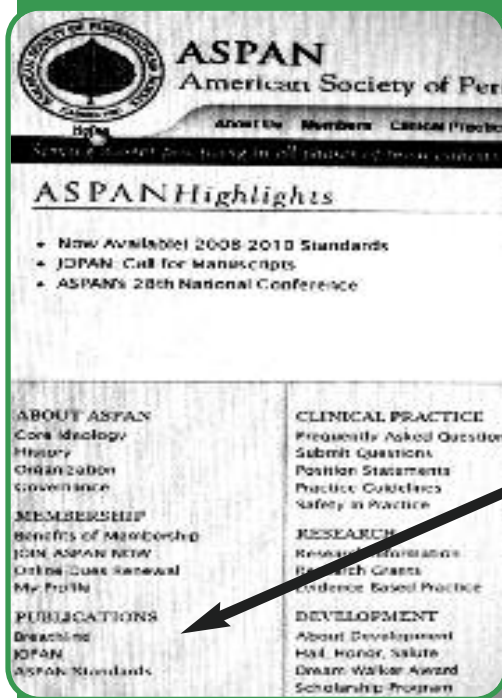

## Pain Legislation Update

*Advocacy Strategic Work Team*

**H**.R. 2994: National Pain Care Policy Act of 2007, introduced by Rep. Lois Capps (D-CA) and Rep. Mike Rogers (R-MI), was a topic of discussion and debate at the 2008 Representative Assembly. The bill sought to amend the Public Health Service Act with respect to pain care by improving pain care research, education, training, access and outreach. The U.S. House of Representatives passed H.R. 2994 in September 2008. The bill was subsequently referred to the Senate and its

Committee on Health, Education, Labor, and Pensions.<sup>1,2</sup>

House bills begin in House committees and, when passed, enter Senate committees. In the 2007-2008 110th Congress, S. 3387: National Pain Care Policy Act of 2008 was introduced and is still pending committee consideration with the session soon coming to a close. Please note that with the huge amount of legislation introduced each year, most bills do not receive any committee consideration and are never reported out of committee.<sup>2</sup>

## Board of Directors Mid-Year Meeting Highlights November 14-16, 2008 ~ Miami, Florida

### COMMITTEE/STRATEGIC WORK TEAM (SWT) UPDATES

**Advocacy SWT:** Continues to investigate collaboration with other nursing groups on endorsing legislative issues and with ASPAN Education Provider Committee to develop informative seminars on the legislative process.

**Clinical Practice Committee:** Maintains the busiest committee schedule. More than 120 questions are answered per month, most within two weeks of receipt. The Celebrate Successful Practices (CSP) program will have a slightly different format this year. Some participants will be giving an oral presentation along with their poster presentation.

**Development:** Eighteen scholarships were awarded in 2008. The certification exam scholarship amount will increase to \$285.00. A new Humanitarian Mission scholarship was approved by the Board and will be offered beginning in 2009. Currently, fourteen vendors have signed on for space at National Conference in Washington, D.C. ASPAN's Silent Auction will offer a new, exciting format. More information will be coming soon.

**Education Approver/Provider Committees:** American Nurses Credentialing Center (ANCC) has awarded ASPAN accreditation for six years. To achieve this honor, a provider must have scored 100% accuracy in meeting very stringent guidelines. The Education Approver Committee continues to assist members with their contact hour approval application process. The Education Provider Committee continues to provide education programs across the country with relevant information presented for all perianesthesia nurses.

**Evidence Based Practice (EBP) Committee:** Research based discharge criteria and hypothermia guidelines are currently under review and, as data becomes available, revision of the standards/guidelines will be recommended.

**Membership/Marketing Committee:** PeriAnesthesia Nurse Awareness Week (PANAW) will be celebrated February 2 - 8, 2009. This year's theme is *Perianesthesia Nurses: Catch the Spirit*.

**Nominating Committee:** Immediate Past President Susan Fossum presented the 2009-2010 candidate slate. Please see pages 4-5 for a complete listing of ASPAN candidates and election information.

**Perianesthesia Data Elements (PDE) Committee:** Published material will soon become a reality. The PDE team continues to work toward production of available data elements in 2009.

**Research Committee:** Thirteen members participated in a Research Workshop offered during the 2008 National Conference. These participants will continue to be mentored and present their information at National Conference in Washington, D.C. It is anticipated that components will be able to participate in research studies in the next year. ASPAN's *Research Primer* is very near completion and should be available online soon.

**Safety Committee:** This committee continues to gather information for Situation, Background, Assessment, Recommendation (SBAR) development relative to patient safety scenarios.

**Standards and Guidelines Committee:** The 2008-2010 *Standards of Perianesthesia Nursing Practice* are available for purchase and are effective December 26, 2008.

**Policies & Procedures/Job Descriptions:** Many ASPAN policies & procedures and job descriptions were reviewed, updated and/or revised.

### BOARD ACTIVITIES

**Go GREEN SWT:** ASPAN will be looking for ways to contribute to the "Go Green" initiatives. This includes an effort to decrease the amount of paper utilized at conferences, seminars and Board meetings and publishing the *Breathline* online. The midyear Board meeting was conducted electronically, with very little paper (agenda only). As we move into the future, emphasis will continue on environmentally friendly ways to conduct our members' business.

**Research:** ASPAN's Research Committee was granted approval to pursue a perianesthesia nurse work environment study. There is a need for further evidence and results will be published.

**Strategic Plan Implementation Ad Hoc:** Members of the Ad Hoc will again meet with Bud Crouch, an organizational consultant, to continue to refine and shape ASPAN's Strategic Plan. The group members will meet in January 2009 as they add new vision and dimension to ASPAN's future.

**Hypothermia Guideline:** Initial revision will be ready in late December or early January. Representative Assembly (RA) endorsement will be requested in April.

**Web Site Redesign:** The new ASPAN Web site has launched! Its increased functionality will allow members a more interactive site including membership sign-up and renewal as well as Conference registrations. The National Office and Web Site Redesign SWT have spent much time facilitating this upgrade. 🌿

# We're Going Green!

Three keys to a greener life in our work, organization and home include the 3 Rs: reduce, reuse and recycle. ASPAN recently commissioned a strategic work team (SWT) to direct its “going green” initiative. For an organization of this size, a greener approach makes a difference in many ways.

ASPAN began this movement by publishing bylaws, policies and procedures, forms, several specialty practice group newsletters, and component president resources on the ASPAN Web site. The purpose of the Go Green SWT is to gather ideas, suggestions and solutions, and then operationalize strategic organizational changes to conserve and become more environmentally friendly.

## Conservation is Key

A few years ago, I attended a Magnet conference in Miami. The host organization offered an online syllabus which allowed me to choose the handouts I wanted to review ahead of time. During the lectures I took notes as needed, and then attached the notes to the handouts. I survived just fine without the big printed syllabus that I originally thought I would miss.

My Internet search for “green meeting guide” produced some helpful hints to direct our activities:

- Provide online registration-confirmation by e-mail
- Communicate and conduct initial deliberations via e-mail
- Make two-sided copies when hard copies are needed

- Use paper with a 50% recycled material
- Recycle name badge holders
- Limit speaker handouts and post the presentations online
- Offer water in pitchers versus individually bottled
- Provide placement of well-marked recycling bins
- Eliminate the use of disposable items such as paper plates and cups

## Virtual Business

The World Wide Web has dramatically advanced and changed the way business is conducted. Last September, at ASPAN's Component Development Institute, attendees were given the opportunity to discuss and share alternative communication methods and educational opportunities. For one session, the presenter was speaking to the group from Michigan while attendees viewed the presentation slides in Salt Lake City. Another real-time Internet demonstration showed how to develop and use an online research questionnaire. Component representatives reported that webinars and conference calls are replacing traditional face-to-face board meetings.

ASPAN is joining the green movement along with many other environmentally friendly organizations. ASPAN will now provide a Web link for conference syllabi. **Beginning with the 2009 National Conference, a printed syllabus will no longer**

**be included with the onsite registration materials.** The session outlines will be available for downloading from a specified Web site beginning April 1, 2009 through June 1, 2009. If desired, every attendee will have the ability to print the entire syllabus, or just the sessions of interest, thereby saving many thousands of sheets of paper!


## Green Theme

ASPAN hosts its 28th National Conference during the same week that the next Earth Day celebration occurs. On April 22, 2009, the spirit of Earth Day offers a perfect way to celebrate many ways that ASPAN can go even greener. Ultimately, your professional organization is committed to caring for resources and the planet.

We understand that change is an adjustment which takes time. Together, with members, ASPAN will become more environmentally involved. ## A Trip to the Emerald Isle *Irish Anaesthetic and Recovery Nurses Association Annual Conference*

In October 2008 I represented ASPAN at the Irish Anaesthetic & Recovery Nurses Association (IARNA) 6th National Conference in Limerick, Ireland. ASPAN *Breathline* Editor Joni Brady, MSN, RN, CAPA, was invited by IARNA to present lectures. Joni was also elected to serve with IARNA as its International Representative/Liaison during the organization's 2008 Annual General Meeting.

Participation at the conference provided an excellent opportunity to discuss international perianesthesia practice similarities and challenges. The variety of

sessions included: advanced trauma, preserving forensic evidence with trauma patients, cardiac shock, difficult airway management, and the bariatric patient. Joni presented "Treatment of the Burn Patient in the Perioperative Setting" and I delivered a lecture on hypothermia. Together, we gave the closing address, "Advocacy in Nursing".

### Shared Practice

While networking with colleagues from several countries, it became obvious that advocacy is a timely, relevant and global topic for nurses. Several nursing and health-related issues dominated the Irish media that week. Public outrage involved a controversial announcement regarding proposed funding cuts for the "over 70" advanced age group and its access to healthcare. Organized marches occurred throughout the country to protest the potential cuts to current services.

A wrong site kidney removal sparked concern over surgical safety and the need to implement universal protocol for wrong site/side surgery. Nursing school funding was being cut 16% with

one of the solutions for their nursing shortage being the reliance on foreign nurses. Each example illustrates why nurses benefit greatly from collaborative pursuit of evidence based practice and unity of voice regarding workplace shortages and working conditions.

A visit to the Limerick's Mid-Western Regional Hospital PACU allowed us to see how the unit was set up and managed. It was interesting to see "trolleys" (gurneys) with individual, stylish temperature control duvet covers! Thank you to IARNA Immediate Past Chair Fionuala O'Gorman, MSc, Ed, BSc, Hons, and the entire conference committee for such wonderful hospitality throughout the conference.

I greatly value the opportunity to participate in this conference and thank ASPAN's leadership for supporting representation at international conferences. Although our practice settings may be oceans apart, this experience validated that many patient care issues and the fundamental desire to provide optimal care are shared by perianesthesia nurses worldwide. 🌿

# Frequently Asked Questions

## Clinical Practice

*The Clinical Practice Committee receives many questions via the ASPAN Web site each month. Committee members then research the answer and respond to the query. This is one frequently asked question.*

**Q:** *How long should we keep patients in the PACU after they have received a narcotic?*

**A:** Several factors must be kept in mind when evaluating a patient for discharge from Phase I or Phase II PACU after narcotic (opioid) administration. Such factors include the specific drug's dosage, route, onset of action, peak action, half-life and duration of action.

Intravenous (IV) drugs have a quicker onset and shorter duration of action. Most IV opioids, including morphine, hydromorphone (Dilaudid) and Fentanyl, have a 1-5 minute onset of action and peak within 5-20 minutes. The duration of action for morphine and hydromorphone is 2-4 hours, while the duration of action for Fentanyl is 30 minutes to 1 hour. Morphine and Fentanyl have a half-life of 3-4 hours, while Dilaudid has a half-life of 2 hours. Oral opioids have an onset of 30-60 minutes and peak in 60-90 minutes.



### Stay or Go?

The nurse must always consider patient safety when assessing a patient for transition to the next level of care. IV

drugs peak in 5-20 minutes. It is prudent for the nurse to closely observe and assess a postanesthesia patient during this time period because adverse respiratory effects can occur.

Patients will generally oxygen de-saturate when they are not stimulated. A nurse should monitor a Phase I patient after opioid dosing to assess how he/she may respond without PACU stimulation upon return to a quiet patient room. Ensuring that a patient can metabolize a narcotic without concurrent oxygen de-saturation is a key component of safe patient transfer to another level of care.

When an oral narcotic is to be administered, the nurse should ask the patient if he/she received this medication before and, if so, was it effective? If the patient answers in the affirmative, the nurse can administer that same medication with relative assurance that it will be effective and the patient will be safe.

If a patient has never received a prescribed oral pain medication, the dose can be administered just prior to transitioning to Phase II care. This allows time for the medication to take effect, generally in 30-60 minutes. The Phase II nurse can assess for any adverse reactions and evaluate whether the medication was effective for pain management.

### Stay Safe

The goal of observation after medication administration is to progress the patient to the next

phase of care in the safest, most efficacious manner. So, what is an appropriate time frame for discharge after opioids administration? Because IV narcotics generally peak in 20 minutes along with any adverse respiratory effects, 30 minutes after administration is generally a safe



time to discharge the patient from Phase I care. With oral opioids administration, the nurse can observe the patient and assess for medication effectiveness in 30-60 minutes. If no untoward reactions are encountered during this time period, the patient can transition to home.
