Greetings to all ASPAN members. I enjoyed seeing all my friends again in the fun city of brotherly love in Philadelphia, PA. Your Board of Directors met for the Preconference BOD meeting, and then the Representative Assembly meeting the following day. The BOD meeting was called to order by President Jenny Kilgore. All board members were present. The agenda went as planned with a few additions, revisions, and deletions to the agenda.

Policy Revisions, Votes, and Additions

Revised and new policies include:

- All previous BOD meeting minutes reviewed, revised, and approved
- SPG Coordinator requirement policy for two newsletters changed to two newsletters/informational flyers, or four virtual meetings. They can replace one newsletter for two "Virtual Meetings" (See new requirements for full details)
- Dream Walker Award was retired
- FASPAN policy revised to include retired category members and reduced fee for those members
- The BOD endorsed the Clinical Inquiry Resolution to change "Research" to be inclusive to "Clinical Inquiry"
- The BOD endorsed the Waste Anesthesia Gas / WAG Position Statement
- The BOD endorsed a position statement on Contemporary Social Issues
- The BOD endorsed a new Standard: Family-Centered Care
- The BOD endorsed Principles of Perianesthesia Nursing Practice
- The BOD endorsed the 2023-2024 ASPAN *Perianesthesia Nursing Standards, Practice Recommendations and Interpretative Statements*

President's Initiatives and Strategic Plan

President Kilgore shared a detailed president's initiatives report discussing a robust amount of work she has completed while in office. Vice President/President-Elect Connie Hardy Tabet followed with the executive summary of the Strategic Plan. You will be excited to see the new Strategic plan updates and how ASPAN is leading as a professional organization. (This information will be shared in an upcoming issue of *Breathline*).

Next, all ASPAN committee/SWT/Editors/Liaison/Officer/SPG/and Region Reports were presented. A treasurer review was conducted to detail ASPAN's profits, losses, and financial stability.

Further Agenda Items

Further discussions were had regarding major changes for ASPAN co-coordinators and succession planning.

Representative Assembly Highlights

President Kilgore called to order the Twenty-Fifth Representative Assembly. An informal session was held in the morning with President Kilgore delivering her presidential report, and Treasurer Lori Silva delivering the financial report.

A total of 92 duly credentialed representatives were present, a quorum was established. There were several resolutions brought before the assembly and approved:

- Approved - The addition of a new principle to the Standards document: Current: Principles of Perianesthesia Nursing Practice I. Perianesthesia Principles for Ethical Practice II. Principles of Safe Perianesthesia Practice Proposed change: addition of a 3rd Principle: III. Principles of Perianesthesia Nursing Care
- Approved - The addition of a new standard to the Standards document: Proposed a New Standard to Standards of Perianesthesia Nursing Practice: III. Family-Centered Care.
- Approved - The addition of a new position statement to the Standards document: Proposed Addition to Part 5 – ASPAN Position Statements: A Position Statement on Contemporary Social Issues
- Approved - 2023-2024 ASPAN *Perianesthesia Nursing Standards, Practice Recommendations, and Interpretative Statements*
- Approved - Joint Position Statement: A Position Statement on Waste Anesthesia Gases Outside of the Operating Rooms developed by ASPAN and supported by the American Industrial Hygiene Association
- Approved - The removal of the president of the American Board of PeriAnesthesia Certification as ex-officio member of the ASPAN Board of Directors
- Approved – Revised Representative Assembly Standard Procedures
- Approved - The change of dues assessment from the Representative Assembly to simply just state assess dues as determined by the Board of Directors
- Approved - Proposed Bylaws Amendment Section 5.4.6 Director for Research Name Change to Director for Clinical Inquiry
- Approved - The written notice time frame for special meeting be changed from 30 to 15 days written notice.

President Kilgore thanked the representatives for their service and announced the results of the election to the RA. With no further business, the meeting was adjourned. 🌿

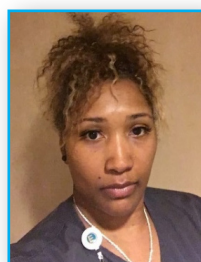

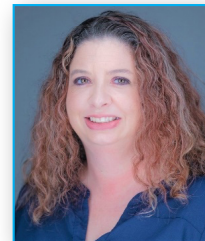

Clinical Practice Hot Topic: *How We Treat Each Other Matters*

There is an alarm going off in the PACU. The constant noise is heard by the other team members, but they don't go to investigate. As a CRNA is walking by the bay, he notices the alarm is for a pulse oximeter reading of 72% and he immediately jumps in, attempting to get the patient to breathe; moves to using a bag-valve-mask, gets more help, and eventually intubates the patient. The nurse who was assigned this patient was in the isolation room admitting her fresh post-op patient.

Why did this happen? Incivility in the workplace can adversely affect patient safety.¹ The nurse assigned to this patient was perceived by others as the department bully. She complained about the other team members, frequently went to human resources to discuss how others were bullying her, and was vocal about the lack of teamwork in the department. Other members of the team felt she was lazy, did not offer to help anyone else, and didn't accept others' advice about patient care. The other nurses admitted to hearing the alarm. The reason they did not respond was they felt the assigned RN frequently ignored her alarms, and they said they were tired of taking care of her patients for her.


The situation was a mess. Incivility had led to an adverse outcome for a patient. If the CRNA had not been walking by, the patient quite possibly could have progressed to a full code situation. How do we address these situations? How do we address incivility by our teams to each other?

Managers have an obvious role in this. Behaviors need to be addressed in a consistent manner. It's difficult to have a conversation with someone and inform them they are perceived by others as lazy and unwilling to help. ASPAN recommends having policies and procedures in place to address behaviors.² Managers need to be diligent about addressing these issues. Coaching sessions should include clear expectations, and will need to occur frequently to ensure the behavior does not continue.

RNs at the bedside need to be aware of their own behaviors. Building a team which is willing to engage in authentic dialogue with each other is a necessity. This is not just a management issue. Nurses need to support each other, putting the patient's care at the forefront of everything they do. Discuss behavior openly. Don't pretend there isn't a bully in the department. Emphasize how important it is for everyone in the department to respond to alarms and requests for help. The PACU is an environment which requires effective teamwork. Develop a behavior contract which clearly sets the expectations for every member of the department.

Incivility in the workforce is dangerous. As nurses are faced with increased demands to meet the needs of our patients, it is imperative we recognize how we treat each other and the safety issues incivility can present for our patients. We need to focus as nurses on taking care of ourselves and each other. As nurses, we need to lift each other up, work as a team, and support each other to provide the best patient care possible.

Lois had a very large hand in steering perianesthesia nursing to where it is today. She literally touched thousands of lives. Below are just a few stories from the dozens of tributes that came in for Lois. Even though I could not print all of them, the theme was overwhelmingly the same, as you will read in these tributes. She was a LEADER and inspired others to take on the challenges in advanced education, writing articles, publishing, and editing. She was an esteemed ASPAN leader, and she mentored nurses to become leaders in her Rocky Mountain component and in ASPAN. Lois was a born educator, and she used her common-sense approach for teaching and preparing for certification which made her classes chosen first at conferences and always well attended with standing room only. She had the ability to make each experience in nursing and in life exciting. There were few challenges that she did not accept, and she was always ready for her next big adventure. Sharing time or travel with Lois was never dull! You cannot describe all Lois was in a few words. I saw her as a true "Renaissance person," a person who has wide interests, highly educated, expert in several areas, and charismatic. She had all these attributes.

Lois had a way of making tedious things interesting, used her quick wit and smarts to destress situations, and always found some humor in the everyday tedium. We all know that "Schick Happens" was her motto and is funny, but it was truly our blessing that it happened.

It is easy to think about Lois as larger than life and in many ways she was. But being a RMPANA member, we were all fortunate to see her humor and her candor. We benefitted from her tremendous knowledge base that she shared so willingly. Although Lois belonged to the world of nursing, we were so proud to call her our own.

To me, Lois was always interesting to be with at our meetings. She welcomed me as a newcomer about 20 years ago as she did with everyone that walked into a RMPANA meeting. How would any new member know she was the ultimate resource of all things nursing while experiencing her humble involvement? She would frequently sit in the back of a meeting (sometimes closing her eyes!) Wearing a t-shirt, camera around her neck, she would gather people to her for photos shouting “Cheers, beers and brassieres” instead of “cheese.” I didn’t realize her many, many accomplishments until I went to conference in Texas and watched her speak as our new ASPAN president.

Lois was always fun to be around and frequently held our education meetings at her house. As she served us mimosas during a brunch meeting, I started to feel a little tipsy after two drinks. I was a little confused by that, having had them before, so I mentioned it to Lois and she said, “It’s probably the Grand Marnier I put in them also.” Everything Lois did packed a punch.

One of my favorite memories was the day I went to Nashville for the start of my conference. We saw each other at the Nashville baggage claim after being unaware we were on the same flight. ASPAN hires a car to come for the president and I suggested Lois come with me to the Gaylord. After some arguing, she agreed, and I had the pleasure of having Lois to myself for about 30 minutes. It is a small amount of time I still cherish, chatting and having someone so amazing look at me and tell me, “You done good kid.”

This past summer, after learning about her illness, I went to Lois’ house for her birthday celebration. Since this is Colorado, and Lois did so many lectures on marijuana, I got some edibles for her, thinking it might be funny but also help with pain. What I later found out is she asked Terry Clifford to hide them because she was nervous someone might see them. Terry and I wonder to this day what ever happened to them.

I am forever grateful that Valerie Watkins and I went to see Lois the day before she left Denver to go home to Iowa. Nancy O’Malley was kind enough to let us know and get us in to visit her in hospice. We chatted, she told us she had made peace with her spirituality and was trying to think of some way to involve the hospice nurses in ASPAN. (Always thinking outside the box.) As she tired from the visit and we knew we reluctantly needed to leave, I was able to tell her how much I loved her, and she shared the same with me. Many nurses have known Lois longer than me (only 20 years, not bad), but I always felt like we shared a secret. I know many must have felt the same way because Lois had that rare gift of making everyone feel special.

“Schick happened” and we are all the better for it.

There are so many words to describe Lois Schick. To me, she began as an idol, became a great mentor, and then a tremendous friend. She was an incredible part of RMPANA, and instrumental in it becoming a component. I first met Lois at a RMPANA meeting in 1986, although I really didn’t “meet” her at this meeting. She was at the front of the room, I was in the back, and I quickly learned what a strong presence she had and how she loved and influenced perianesthesia nursing. It didn’t take long until Lois, in her remarkable and humble manner, quickly encouraged my involvement in RMPANA. She wanted to meet everyone, made everyone feel welcome and valued. I was fortunate to work with her as a RMPANA officer, and also as a member of the RMPANA education committee for 10 years, when we first created our infamous “Retreat In the Rockies.” She was always great to work with. As we grew in our friendship, she encouraged my involvement in ASPAN as well. My first time on the ASPAN BOD, she was Treasurer, and I was in that forgettable role of Chair, Council of Component Presidents. She was there for me as I learned the ropes and struggled, trying to figure out the reason for my position. I was also involved, with her encouragement, in the Clinical Practice Committee and the Standard and Guidelines work team. Then, as she was going to become ASPAN’s president in 2008, she encouraged me to run for the position of Director for Clinical Practice. I was elected to this position for 2008-2012, and was a benefactor of her knowledge, mentoring, and collaborative ideas. In 2008, she asked me what I thought about transitioning to teams for the Clinical Practice Committee, instead of the CP Director overseeing all the members. We did, and it made the director’s role so much more manageable.

That practice, Lois' idea, is still in place today. She was always encouraging. She was such a cheerleader for others! It was never about herself. She also encouraged my writing, a passion of mine. I don't know how she knew this about me, but Lois had an incredible sense about other peoples' talents. I took her on, with her encouragement, and have been a contributor to her and Pam Windle's Core Curriculum, contributed to other perianesthesia texts, and also applied for the position of editor of *Breathline*. Lois was humble, friendly to everyone, and would be the last person to talk about herself or her accomplishments. I miss her so much. You could just call or text her at any time, day or night, and she would be there for you. Her perianesthesia knowledge is second to none. One of my famous stories about her is having dinner, sitting next to her, and she would just start talking about something like muscle relaxants! For me, that was a topic I certainly needed to study over and over again to pass the certification tests. For Lois, these words just flowed out of her mouth...and then on to another subject, we would go on eating and drinking!

I was fortunate to spend an hour and a half with Lois at hospice the day before she left for Iowa (wonderful Nancy O'Malley arranged these visits, so we didn't tire her out). I was able to tell her everything I wanted to say, open and honest, she did the same with me. I'll never forget the look in her eyes when I was leaving and turned around to say goodbye. We both knew we would not see each other again in this life. I am so grateful I had Lois in my life. I am still having a hard time knowing she is not around anymore. But, I am confident she is looking down on all of us, saying "Cheers and brassieres!"

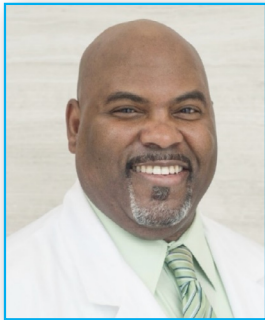

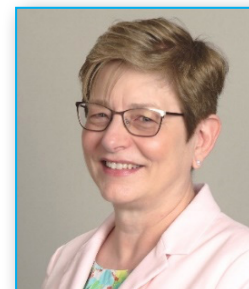
